## **Nomination Form - Fellow Membership**

Fellow membership is the highest level of APTUK membership and recognises developed expertise and sustained professionalism. Being awarded a fellowship is the highest honour that can be bestowed upon a member.

The membership category of Fellow is achieved through peer nomination. To be eligible to be nominated members of the Association must demonstrate upholding the values of the Association of Pharmacy Technicians UK (APTUK) demonstrating loyalty to APTUK and the Pharmacy Technician profession, and be well respected by their peers and colleagues.

A Fellowship is awarded in recognition of exceptional professional performance or outstanding service contribution to the Pharmacy Technicians profession or to the Association, on either a local or a national level.

As APTUK is a professional leadership body, it is important that the Fellows of the Association can demonstrate exemplary leadership capabilities.

Nominations may be received from any full member or fellow of APTUK and must be seconded by another full member or fellow of APTUK. Following receipt of the application it will be considered by a judging panel, consisting of members of the Board of Directors and a nominated Fellow.

Subsequently the Board of Directors will approve Fellowship membership as directed under the Memorandum and Articles of the Association Standing Orders.

- How the nominee demonstrates loyalty to the pharmacy technician profession and APTUK
- Examples of how the nominee is respected within the pharmacy technician profession.
- A description of how the nominee demonstrates exceptional professional performance or outstanding service contribution indicating whether this is at local or national level (or both)
- Evidence submitted must demonstrate how the nominee displays the behaviours and attributes, in accordance with the

<u>GPhC Professional standards</u> (https://www.pharmacyregulation.org/sites/default/files/standards\_for pharmacy professionals may 2017 0.pdf)

in their everyday practice. The evidence provided must be mapped to at least **three** of those standards **one** of which **MUST** be leadership.
