Following the announcement of £75m to accelerate the implementation of ePrescribing across the NHS there are going to be a large number of organisations investigating what they need to do. This technology is one of the most challenging of all health technologies to successfully implement, requiring buy-in and change from a wide range of stakeholders. The workshop will explore, with a number of existing users, what the key challenges will be to deliver a successful go-live. It will identify the approaches used and how sites have overcome the issues. It will also highlight where to go for help and will provide a framework which those starting on their ePrescribing journey can use to underpin their work

Developing system leadership in medicines optimisation: Designing the system relationships between STPs/ICSs, providers, commissioners, primary care networks and clinical pharmacists that will enable best value from medicines

The effective use of medicines and population data will feature significantly, and there will be an opportunity to contribute to the development of NHS England's pharmacy and medicines optimisation framework for STPs which is currently in development.
